	<p>Answer:</p> <p>SensOre group has greater than two quarters of funding available at the end of the September 2022 quarter. In the above future operating activities, the net cash from / (used in) operating activities is derived from section 1.9 which includes the one-off research and development tax incentive refund received.</p> <p>During the September quarter total invoices raised were \$0.76m, with cash receipts of \$0.67m received. Collections during the quarter ended 30 September 2022 were impacted by the relative higher weighting of invoices issued in September 2022, offset by cash receipts received relating to invoices raised in the June quarter. With \$0.54m in trade receivables at 30 September 2022, it is anticipated that the flow through cash receipts in the quarter ending 31 December 2022 will be higher than the September quarter. The Company's operating cash flow reported on a quarterly basis is impacted by the timing of payment terms of SaaS and licence agreements, the timing of government grants and research incentives (including from the Intrepid acquisition due to be received in the December quarter) and the timing of implementation fee billing milestones.</p>
